


Free technical assistance and/or 0% financing for BIPOC-led Bay Area nonprofits

The fund supports small/medium sized organizations serving low income, BIPOC communities. We are prioritizing organizations in the arts, health, human services, job creation and stabilization, affordable housing, environmental justice, education and youth services, advocacy and movement building sectors. Technical assistance supports board members, executives, and program staff on a wide variety of financial topics. Loans range from \$25,000 to \$250,000, 0% interest with no application fees, no collateral or guarantees. The loan requests are evaluated based on financial history and expected repayment sources.


AMERICAN NONPROFITS BORROWER SECTORS AND GEOGRAPHY
